Personal data, such as your name, address, email, telephone number, date of birth; Credit card information is gathered.  
Eratos will only ever collect farm data at your request. You can ask us to collect and manage any data that complies with our terms of service

**Why is this being done?**

Farm Data: Data is collected or made available on request from the data owner, generally to connect the data with a service or provider that will increase the value of the data to the data owner.  
Other data about the Farmer or their farm/business: to provide Eratos services to the Farmer.

**Who is the Provider sharing Farm Data with?**

We will only share data to third parties with your express permission

**Is Farm Data being de-identified?**

Farm Data can be de-identified on request, but is not de-identified by default

**How long is Farm Data stored for?**

Personal data will be stored for 7 years. Farm data that the data owner uploads or provides access to Eratos will be stored indefinitely until either the data owner denies Eratos access, removes their data, deletes their Eratos account or requests that their data or account is to be deleted.

When you create an Eratos account, you must accept the terms and privacy policy, this is where you consent to the terms. Consent is tracked against terms by recording the date when consent was given, as well as the version of the terms that have been accepted.

If you choose to share your data with a third party, according to clause of the subscription terms, you must agree to their terms that they will provide to you. Eratos does not manage 3rd party licence agreements, only the controlled sharing of data once those agreements have been made.

**Ensure the Farmer has control over who can access and use their Identifying Farm Data.**

**Meets the code?**

### Provider's comment

Parties nominated by the data owner can have access to farm data. Third parties are defined as other users of the platform and could be anyone, and have access to anything IF and only IF they are allowed by the sharing agreement made by the farmer and the third party.

When a farmer chooses to share their data, they can add the third party user to their space, they will then have permission to see all the farmer data in their space. Alternatively, a farmer can add their data into the third party providers space, so that the third party now has access permissions to the data.

A data owner can remove a third party from their space or remove the data from a third parties space using our permissions and governance capabilities.

Once an account has been terminated, personal and uploaded data can be retrieved by contacting Eratos via Email.
